

SAKKHO® WOODEN TILES - GENERAL CONDITIONS

Delivery: Sakkho® ("Sakkho") undertakes to supply wooden tiles or other ordered products as ordered, in good condition. If delivery is agreed, it is the purchaser's responsibility to meet the conditions of delivery as stated, and also provide clear and safe access to the site. In the interest of the Australian Occupational Health & Safety (OH&S) or equivalent local workplace health and safety regulatory requirements, it is the purchaser legal liability to provide a compliant delivery location. Shipment & delivery will be carried out as set by Sakkho standard **Trading Terms & Conditions of Sale**, complete version available online at sakkho.com

Storage and Acclimation: Timber is a natural hygroscopic material responding to changes in moisture level. As timber absorbs moisture to remain in equilibrium with the surrounding atmosphere it expands; as it loses moisture it shrinks. Timbers such as teakwood have small movement; however, Sakkho recommends wooden tiles to be stored at the installation site protected from rain, snow or direct sunlight for at least two weeks before use to allow the wood absorb or expel humidity, adjust and remain in equilibrium with the ambient atmosphere and moisture level (MC). During the recommended minimum 2 weeks acclimation period, tiles should be kept away from the ground or from newly laid concrete and kept dry. Failure to adjust MC may result in unsafe installation.

Guide to preparing and acclimating tiles:

1. Open available packages - leave all tiles boxed on-site covered.
2. Stack all boxes allowing air to circulate through all tiles.
3. Leave timber to sit for about 2 weeks or more at the installation site.
4. Ideally install during a season with an average humidity level.
5. Protect the timber from moisture during all stages of construction.

Installation: While providing general installation principles, Sakkho does not provide installation or advice related to particular installation; this should be requested from an independent, accredited professional according to your specific project. For installation requiring the use of nails, bolts or screws a pilot hole must be pre-drilled to avoid cracking wooden slats composing tiles. Some projects always require tiles centre and corners to be supported. Sakkho reject all liability related to installation.

Maintenance: Sakkho tile are presented raw, unsealed requiring little maintenance and are very easy to care for. When left unprotected, out in the elements and in favourable weather conditions, timbers such as teakwood will change tint into a light silver colour also known as the "graying process".

- **How to Protect:** various options are available to protect Sakkho tiles such as timber finishes, paints, varnishes, sealants, wax or fire retardants; naturally oily timbers such as teakwood may require an aluminium wood primer prior to painting.
- **Note:** do not make the walking surface slippery by exceeding any necessary maintenance schedule when it is not required regardless of any recommended maintenance schedule.
- **Recommended tools:** paint sprayer, paint brushes or paint pads.

Order Cancellation: Subject to a purchaser or authorized representative accepting and signing this "Model I.D. Form" or equivalent local or translated form available from Sakkho, and cleared payment received in full by Sakkho for invoiced goods, as soon as a commissioned manufacture or delivery of ordered goods is active, Sakkho will consider the order as final. Change-of-mind will not be accepted.

No Returns Policy: It is incumbent upon the purchaser to ensure the correct timber specie, grade, tile model and base type have been ordered; and that a proper check of quantities and tallies has been done by the purchaser prior ordering, at pick up and at delivery. Additional quantity considered as wastage or "extra quantity" should be considered and ordered accordingly by the purchaser.

Recommended Installation

As each Sakkho tile model has a different pattern and a specific base configuration, fixing spots for nails, screws or angled nails will therefore vary. It is important to work with the top and the base of the tile when placing screws or nails.

Additional options for temporary or permanent installations and for placing fasteners on tiles are possible. The space and gaps between slats varies with each tile model; consequently fasteners and the preferred installation option must be selected accordingly.
